## **Upgradation of Existing 20 MLD STP with BNR and Tertiary Membrane Filtration with 3 years of O&M on turnkey basis at Balkapur Nala, Hussain Sagar Lake and catchment area improvement Project**

### **INTERNATIONAL COMPETITIVE BIDDING**

HUDA invites sealed tenders in prescribed form in single stage three cover system for the Upgradation of Existing 20 MLD STP with BNR and Tertiary Membrane Filtration with 3 years of O&M at Balkapur Nala, on Turnkey Basis from reputed firms/JV Consortium with not more than 3 members including the lead member. The tenders will be received by the Vice Chairman at Block 'A', HUDA Commercial Complex, Tarnaka, Hyderabad upto 3.00 P.M on **11.07.08**.

#### **Eligibility criteria:**

- a) The firms/lead members of J.V. shall have the experience of Design, Engineering and construction of at least one STP of capacity 10 MLD and above having Secondary Treatment Process in the last five years and also any member of the Consortium shall have the experience of design, engineering and construction of at least one membrane plant of capacity of 10 MLD and above in the last five years. The Firm/any member of the JV shall have the experience of Operation and Maintenance of one STP/CETP with membrane for 1 year in the last five years.
- b) The minimum annual turn over of the applicant shall not be less than Rs. 300 millions INR (US \$ 7.5 million) and net worth of Rs. 150 million INR (US \$ 3.75 million) for each of the last three years. In case of JV the minimum annual turn over shall be Rs.450 million INR (US \$ 11.25 million) and Net worth of Rs. 225 millions (US \$ 6.3 million) for each of the last 3 years and the lead partner shall contribute atleast 50% of the minimum annual turn over. The firm or lead partner of JV shall have liquid assets / credit facilities of Rs.90 millions INR.

The tender documents can be purchased in person or through an authorized representative by interested applicants upto **13.06.2008** during the office hours from the Office of the Executive Director and Project Manager, Block 'A', HUDA Commercial Complex, Tarnaka, Hyderabad upon payment of Non refundable lumpsum charge of Rs. 5,000/- (Rupees Five Thousand Only) in the form of D.D. drawn in favour of **"Vice Chairman, HUDA"** payable at Hyderabad.
